By signing below, I am agreeing to the following:

- 1) This is a legal and binding contract between the adopter signing below and the governing body of Kelly's Kritters adoption and rescue of Grand Traverse County. I understand that this contract is enforceable by law in the state of Michigan.
- 2) I promise to provide a safe home environment with food, water, toys, and a space to live safely.
- 3) I will provide a veterinary wellness exam, at least once a year and provide the vaccines necessary and recommended by my veterinarian for my pets life style.
- 4) My pet will be an indoor only pet, unless stated below.
- 5) I understand that all risks of injury or loss caused by the animal after the adoption are mine and shall be effective immediately as the date/time of this contract. Kelly's Kritters shall not be held responsible for any loss by injury or damage caused by the adopted animal while in my possession.
- 6) I understand that once I adopt this animal, he/she is my responsibility. **Kelly's Kritters assumes no financial responsibility for medical care required by this animal once I take possession of it.** I acknowledge that I have received medical records for this pet that show the state of health of the animal. I further acknowledge that I will not hold Kelly's Kritters accountable for any medical issues that occur once the pet is in my possession, regardless of the amount of time between the adoption and the medical issue. I acknowledge that I have examined the pet prior to signing this contract and find no signs of injury or illness.

- 7) The adoption shall be regarded as permanent when I take possession of the pet. In the event the adoption fails, or I can no longer keep the pet, I agree to notify Kelly's Kritters immediately and to humanely and safely house the pet until Kelly's Kritters can find another suitable home or a foster home becomes available. Under no circumstances shall I place the pet into another shelter, pet shop, or with another party without the consent of Kelly's Kritters. Under no circumstances shall the pet be released outside to fend for themselves.
- 8) By signing this contract, I agree to the possibility of a home inspection with 14 days of the signature of this contract. If the home is found to be unsuitable for this pet or misrepresented in any way from the application, the pet will be returned to Kelly's Kritters.
- 9) **I understand that the adoption fee is non-refundable.**
- 10) You have entered into this contract knowing that your pet will be or already has been altered. If your pet has not been altered at the time they leave the facility, you will be required to leave a good faith deposit of an additional \$100.00 which will be returned after the alteration is completed. You will have no longer than 60 days to have the alteration done, Provided only by Cherry Capital Pet Hospital, located at 4470 Norton Rd. Grawn. (231) 493-8144.
- 11) If the contract is breached by the person adopting this pet, by not following thru with the alteration, you agree to pay the liquidated damages of the greater \$100.00 or actual responsible costs inquired by the shelter to enforce the contract. **By initialing here, you are acknowledging that you have been informed with this clause by Kelly's Kritters.** _____
